Climate Alingment

The organization's strategy considers different climate-related scenarios, including a scenario of 2°C or less. As a result of the Paris Agreement signed in 2015, it was defined that goals adopted by companies would be considered science-based if they were aligned with the decarbonization level necessary to keep the global temperature increase below 2°C as described by the fifth report of the Intergovernmental Panel on Climate Change (IPCC).

Based on this guidance, Colombina has decided to join this global initiative and set our science based target for the year 2030 in line with Colombia's National Contribution. Accordingly, our goal is to reduce Scope 1 and 2 emissions by 21%.

We report on risks and opportunities related to climate change and promote the reduction of greenhouse gas emissions through the Carbon Disclosure Project (CDP).

We have adopted the TCFD framework to disclose financial information on risks and opportunities related to climate change, covering its four key areas.
